CHALLENGE

- ▶ Transformational KYC program was initiated for replacing existing customer risk profiling platform with Actimize
- ▶ Needed a trusted partner who could bring thorough functional testing expertise and the right approach
- ▶ Highly complex banking interface model and its overall architecture
- ▶ Limited capacity at the clients end to support the test assurance program, for rolling out the new application across 9 countries.



SOLUTION

- ▶ Phase wise scalable strategy was laid for the below set of countries
 - Phase 1 – Singapore, UAE, Hong-kong, India, Malaysia
 - Phase 2 – Nigeria, Zimbabwe, Pakistan and Bangladesh
- ▶ KYC rules for each country were analysed in-depth for reflecting the right testing strategy
- ▶ A mix of early engineering proficiency and a traditional testing method was used
 - Single instance global requirements build was catered by Agile model
 - E2E country specific build was served through waterfall method
- ▶ Comprehensive stages of UAT, Regression, Dress Rehearsals (DRH) and Business Validation testing were conducted for continuous quality
- ▶ Pre-built selenium scripts were provisioned for faster time to market
 - For data sync validation between core systems
 - For regression suite creation and execution



RESULTS

- ▶ Successful Go-Live of new risk profiling platform across 9 countries with zero functional defects
- ▶ 50K+ KYC rules were assured thoroughly for 1.5m customer records
- ▶ Higher standards of QA practices were set, by meeting complex and challenging multi-country delivery plans.
 - Supported Business Users while performing test execution during DRH and Go-Live UVT events
- ▶ Fully compliant with bank's Internal Audit requirements
